SPRAY DRIFT RESTRAINTS

DO NOT allow bystanders to come into contact with the spray cloud.

In intervening year, use other recommended fungicides.</p>

Mixing

Pour Imtrade Metalaxyl 250 EC Fungicide directly into water in the spray tank and mix well. Beware of solvent vapours while handling the concentrate and working near an open spray tank.

Some naturally occurring individual fungi resistant to Imtrade Metalaxyl 250 EC Fungicide and other Group 4 Fungicides may exist through normal genetic variability in any fungal population. The resistant individuals can eventually dominate the fungal population if Imtrade Metalaxyl 250 EC Fungicide and other Group 4 Fungicides are used repeatedly. These resistant fungi will not be controlled by Imtrade Metalaxyl 250 EC Fungicide and other Group 4 Fungicides, thus resulting in a reduction in efficacy and possible yield loss.
